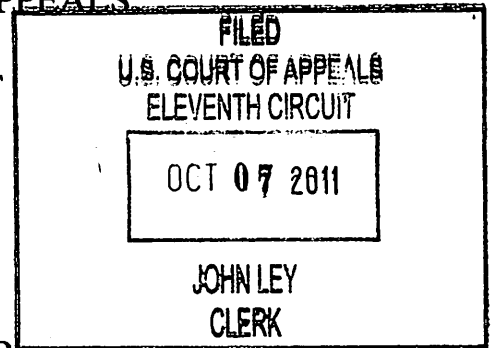

ORDER BY THE COURT:

The Court orders the Defendants-Appellees the State of Alabama and the Governor of Alabama, Robert J. Bentley, et al., to file by no later than 3:00 p.m. on Tuesday, October 11, 2011, a response to (1) the Plaintiff-Appellant United States of America's Motion for Injunction Pending Appeal and Temporary Injunction and (2) the Plaintiffs-Appellants Hispanic Interest Coalition of Alabama, et al.'s Motion for Preliminary Injunction Pending Appeal and for Expedited Appeal.

Any reply by the Plaintiffs-Appellants shall be filed by no later than 10:00 a.m. on Wednesday, October 12, 2011.

The Court grants the Plaintiffs-Appellants Hispanic Interest Coalition of Alabama, et al.'s Motion for Leave to Exceed Page Limit by 7 pages as to the

Motion for Injunction Pending Appeal. The Defendants-Appellees' response shall not exceed the combined total number of pages of the Plaintiffs-Appellants' motions in the two appeals.

The Court also expedites the briefing on the merits of these appeals and any cross-appeals. The Plaintiffs-Appellants' opening briefs on the merits shall be filed on or before October 31, 2011. The Defendants-Appellees' response briefs on the merits shall be filed on or before November 22, 2011. The Plaintiffs-Appellants' reply briefs on the merits shall be filed on or before November 29, 2011.

The Clerk is directed to expedite this appeal to the next oral argument slot that is available after November 29, 2011. The Clerk will advise the parties when this matter has been calendared.
